**LEASE TERMINATION NOTICE AND RELEASE
DATED AS OF JANUARY 13, 1995**

WHEREAS, the undersigned, Boston and Maine Corporation, a Delaware corporation, as lessee ("B & M"), and Arlington-Integrated (Rail), Inc., a Delaware corporation now known as Integrated Rail Corp. ("Rail"), as lessor, have entered into a Lease of Railroad Equipment dated as of August 1, 1979 (the "Lease of Railroad Equipment") covering two hundred railroad boxcars bearing BM reporting marks and road numbers 3200 through 3399 inclusive (the "Equipment");

WHEREAS, the Lease of Railroad Equipment was filed with the Interstate Commerce Commission on August 13, 1979 and assigned recordation number 10740-B;

WHEREAS, Rail assigned all of its right, title and interest in and to the Lease of Railroad Equipment to IBIS Associates Limited Partnership, a Connecticut limited partnership ("IBIS"), as collateral security, pursuant to an Assignment of Lease dated as of June 30, 1980, which Assignment of Lease was filed with the Interstate Commerce Commission on July 22, 1980 and assigned recordation number 10740-D (the "Assignment of Lease");

WHEREAS, the term of the Lease of Railroad Equipment expired on October 15, 1994 and has not been renewed, and B & M wishes to provide notice thereof for the public record;

NOW, THEREFORE:

(i) B & M does hereby acknowledge the expiration of the Lease of Railroad Equipment on October 15, 1994 and does hereby, as of this date, release and discharge all of its right and interest in the Lease of Railroad Equipment and in the Equipment; and

(ii) IBIS and Rail do hereby acknowledge and agree to all of the foregoing and do hereby, as of this date, release and discharge all of their respective right and interest under the Assignment of Lease.
