



THIS TERMINATION OF LEASE OF RAILROAD EQUIPMENT ("Termination") is dated as of July 11, 1997 by HELM FINANCIAL CORPORATION, a California corporation ("Lessor").

1. <u>Recitals</u>. Lessor entered into the Lease of Railroad Equipment dated as of August 22, 1990 ("Lease") with Weirton Steel Corporation, a West Virginia corporation, with respect to the twenty (20) railcars described in <u>Schedule A</u> attached hereto.
