RELEASE AGREEMENT

INTERSTATE COMMERCE COMMISSION

RELEASE AGREEMENT dated this 1st day of August , 1983, by and between NCNB National Bank of North Carolina (Formerly North Carolina National (the "Bank") and Evans Railcar Leasing Company ("Evans"), by name Bank) change successor in interest to United States Railway Leasing Company and United States Railway Equipment Company.

WITNESSETH:

WHEREAS, the Bank and Evans entered into a Loan Agreement dated March 15, 1972 ("Loan Agreement") Issue K, whereby Evans became indebted to the Bank in an amount as evidenced by a Mortgage Note ("Note"); and

WHEREAS, to secure payment of principal and interest on the Note, Evans granted the Bank a Chattel Mortgage dated March 15, 1973 ("Mortgage"), ICC recordation #6528 in certain railroad equipment ("Equipment"); and

WHEREAS, Evans has fully paid its obligations with respect to the Loan Agreement and desires and is entitled to a release of the Bank's Mortgage in the Equipment;

NOW, THEREFORE, the parties hereto agree as follows:

1) The Bank acknowledges that Evans has fully paid its obligations with respect to the Loan Agreement. Accordingly, the Bank hereby releases its Mortgage and any other rights which it may have in the Equipment.

2) The Loan Agreement and Chattel Mortgage dated March 15, 1973 are hereby terminated and neither party thereto shall have any further obligations thereunder except for the obligations under this Release Agreement.
