WHEREAS, UNITED STATES RAILWAY LEASING COMPANY, an Illinois corporation (the "Company") has heretofore executed and delivered a certain Chattel Mortgage (Railroad Equipment Security Agreement) dated March 15, 1972 (the "Security Agreement") from the Company to THE MARINE MIDLAND BANK-NEW YORK, a banking association chartered under the laws of the State of New York (the "Mortgagee"); and

WHEREAS, the Mortgagee has loaned to the Company the principal amount of \$1,750,000 as evidenced by that certain 8-1/4% Equipment Promissory Note, Issue M of the Company payable to the order of the Mortgagee and dated May 26, 1972 (the "Note"); and

WHEREAS, as security for the Note and the performance of the obligations set forth in the Security Agreement, the Company has granted a security interest to the Mortgagee in certain mortgaged property as defined in the Security Agreement (the "Mortgaged Property"); and

WHEREAS, the Security Agreement has been filed for record in the offices of the Interstate Commerce Commission in Washington, D.C. on May 1, 1972 as Recordation No. 6574; and

WHEREAS, pursuant to two certain Assignments of Lease, both dated as of March 15, 1972 (the "Assignments") as additional security for the Note, the Company has assigned to the Mortgagee all of its rights, titles and interest in and to two Lease Agreements between the Company

and the Boston and Maine Corporation, the first lease dated July 1, 1968 and recorded on July 29, 1968 in the offices of the Interstate Commerce Commission in Washington, D. C. as Recordation No. 4972, and the second lease dated September 25, 1968 and recorded in said offices of the Interstate Commerce Commission as Recordation No. 5068 (collectively referred to as the "Leases"); and

WHEREAS, the Assignments of the Leases have been filed for record in the offices of the Interstate Commerce Commission in Washington, D.C. on May 1, 1972 as Recordation Nos. 4972-A and 5068-A respectively; and

WHEREAS, the Security Agreement provides that upon performance of the covenants contained therein and payment to the Mortgagee of the full amount of both principal and interest of the Note secured thereby, said Agreement shall be and become void and of no further force and effect; and

WHEREAS, the Company has performed the covenants contained in the Security Agreement and the Company has paid, or contemporaneously with the execution and delivery hereof by the Mortgagee will pay, the Note;

NOW, THEREFORE, the Mortgagee does hereby release, reassign, remise and quit-claim to and unto the Company all the rights, titles and interests which the Mortgagee acquired or may have acquired under and by virtue of the Security Agreement in and to the Mortgaged Property, and the Mortgagee does hereby release, reassign, remise and quit-claim to and unto the Company all of its estate, rights, titles and interests in and to the Assignments and the Leases assigned thereunder.
