TO THE SECURITY AGREEMENT
BETWEEN ITEL RAIL CORPORATION ("DEBTOR")
AND CHEMICAL BANK, AS AGENT ("AGENT")

THIS AMENDMENT NO. 1 ("AMENDMENT") TO SUPPLEMENT NO. 3 ("Supplement No. 3") to the Security Agreement, as amended and supplemented (as amended and supplemented, the "Security Agreement"), dated as of December 21, 1989, between Debtor and Agent, which was filed and recorded with the Interstate Commerce Commission ("I.C.C.") pursuant to 49 U.S.C. Section 11303(a) on December 26, 1989, and given Recordation No. 16667, is entered into as of the ZI and of October, 1991.

WHEREAS, Exhibit A-3 ("Exhibit A-3") to Supplement No. 3, which is a complete restatement of Schedule 3 to the Security Agreement and reflects changes from December 21, 1989, through and including June 30, 1991, in the number of units and reporting marks of Pledged Rolling Stock (as defined in the Security Agreement), was added to the Security Agreement in lieu of the original Schedule 3 thereof; and

WHEREAS, certain railcars which are subject to a security interest in favor of Yasuda Trust and Banking Company, Limited (the "Yasuda Cars") and were released by Agent pursuant to Release No. 2 dated as of May 15, 1991 ("Release No. 2"), which was filed and recorded with the I.C.C. pursuant to 49 U.S.C. Section 11303(a) on May 29, 1991, and given Recordation No. 16667-F, were inadvertently included in Exhibit A-3; and

WHEREAS, Exhibit B-3 ("Exhibit B-3") to Supplement No. 3, which is a complete restatement of Schedule 4 to the Security Agreement and reflects changes from December 21, 1989, through and including June 30, 1991, in the number of units and reporting marks of railcars owned by Debtor that are not subject to the security interest granted under the Security Agreement, was added to the Security Agreement in lieu of the original Schedule 4 thereof; and

WHEREAS, certain railcars which are subject to a security interest in favor of NMB Lease NV (the "NMB Cars") and were released by Agent pursuant to Release No. 1 dated as of January 24, 1991 ("Release No. 1"), which was filed and recorded with the I.C.C. pursuant to 49 U.S.C. Section 11303(a) on May 29, 1991, and given Recordation No. 16667-D; and the Yasuda Cars released by Release No. 2; and certain railcars which are subject to a security interest in favor of Pitney Bowes Credit Corporation and Deutsche Credit Corporation (together, the "Pitney/Deutsche Cars") and were released by Agent pursuant to Release No. 3 dated as of June 3, 1991 ("Release No. 3"), which was filed and recorded with the I.C.C. pursuant to 49 U.S.C. Section 11303(a) on June 13, 1991, and given Recordation No. 16667-G, were inadvertently omitted from Exhibit B-3; and

WHEREAS, Debtor and Agent acknowledge that the Yasuda Cars should have been and were intended to be omitted from Exhibit A-3 of Supplement No. 3 and the NMB Cars, the Yasuda Cars and the Pitney/Deutsche Cars should have been and were intended to be included in Exhibit B-3 of Supplement No. 3, all retroactive to June 30, 1991.

NOW, THEREFORE, the parties hereby agree to amend Supplement No. 3 as follows:

- 1. All capitalized terms used herein shall have the meanings ascribed to them in the Security Agreement unless otherwise stated.
- 2. Retroactive to June 30, 1991, the Yasuda Cars subject to Release No. 2 and identified on Schedule 1 hereto are hereby deleted from Exhibit A-3 of Supplement No. 3.
- 3. Retroactive to June 30, 1991, the NMB Cars subject to Release No. 1, the Yasuda Cars subject to Release No. 2 and the Pitney/Deutsche Cars subject to Release No. 3, all of which are identified on Schedule 2 hereto, are hereby added to Exhibit B-3 of Supplement No. 3.
- 3. Except as expressly modified by this Amendment, all terms and provisions set forth in the Security Agreement and Supplement No. 3 shall remain in full force and effect.
