The Trust Agreement was first recorded in the office of the Secretary of the Interstate Commerce Commission on January 25, 1980, under Recordation No. 11425.





Supplemental Agreement dated as of July 31, 1984 by and between Continental Illinois National Bank and Trust Company of Chicago, as Trustee, and General American Transportation Corporation, a New York corporation.

Whereas, the parties hereto entered into an Equipment Trust Agreement dated as of November 1, 1979 (the "Agreement") creating General American Transportation Corporation Equipment Trust, Series 76, which Agreement was filed and recorded with the Interstate Commerce Commission pursuant to Section 11303 of the Interstate Commerce Act on January 25, 1980, Recordation No. 11425; and

Whereas, the parties hereto wish to amend Schedule I to the Agreement;

NOW, THEREFORE, the parties hereto agree that Schedule I to the Agreement is hereby amended by:

(a) deleting therefrom the units of Trust Equipment described in Schedule I attached hereto, and

(b) substituting therefor the units of Equipment described in Schedule II attached hereto.
